CHAMPIONSHIP - Sandi Rousseau

The Championship Committee has focused on processes to evaluate and improve our national championship meets in both the conduct of the meet as well as attracting new host groups and facilities.

In 2000 we have served as a resource for two successful national championship meets, The short course championship hosted by Indy Swim Fit at the Indiana University Natatorium in May attracted 1390 swimmers to Indianapolis, Indiana. Long course championships hosted by Maryland Masters were held at the University of Maryland, Baltimore County, in August and had 1380 competitors. This meet was the largest long course meet in USMS history.

We have continued to work with the USMS web master in streamlining and improving the on line entry procedure and had a favorable increase in usage. Short course nationals had a 25% usage rate for on line entries and long course usage increased to 43% of the swimmers entering on line. This year we coordinated with the registration database from USMS headquarters resulting in smoother registration and club affiliation confirmations.

A new procedure for assisting the meet host in enforcing our safety precautions during warm-ups was instituted and utilized at both championship meets. This consisted of each swimmer being asked to sign a form at meet check-in stating he/she is aware of the safety regulations including no diving during warm-ups except in designated lanes. Notice of a new marshalling policy was posted in many obvious places, and adherence to the safety procedures has improved.

Our processes for contacting possible host facilities and LMSC chairmen within the USMS bidding areas were updated and improved resulting in a significant increase in interest in hosting a USMS national championship meet. This process consisted of a letter being sent to each LMSC chair within the bidding area and to all known facilities within the bid area that are capable of hosting a national championship meet.

We have continued to do the more mundane yearly tasks of updating the contracts and revising manuals and forms to assist the meet hosts. We are also working more closely with the USMS National Sponsor Liaison to improve our relationships with USMS sponsors. Championship liaisons for the 2001 Nationals are actively working with Santa Clara, CA, and Federal Way, WA, in preparations for these championships.

A large project currently being completed is a survey of USMS Top Ten swimmers. The survey consisted of 25 questions, and the purpose is to provide USMS with comments and ideas regarding the current formats of our national championship meets, possible changes to these formats, and any other ideas to enhance our national meets. The data from this survey will be analyzed prior to convention for discussion at the committee meeting. It is hoped that this information will guide the Championship Committee toward any changes that the USMS membership would like to see at our championship meets.

COACHES – Scott Rabalais

The Coaches Committee continues its programs dealing primarily in the education of coaches and swimmers and the identification and recognition of coaches. Further, it is a goal of the Coaches Committee to advance the profession of Masters coaches across the country, from sea to shining sea.

Our system of identifying Masters coaches has been implemented through LMSC and USMS registration processes. To date, nearly 900 coaches have been identified, an increase of over 400 coaches from our previous hodge-podge database. The Coaches Committee will continue to work with the LMSC registrars to ensure that all coaches are accounted for.

One of the most significant additions to the work of the Coaches Committee over the past year has been to establish the position of the LMSC Coaches Representative. The job of the Coaches Rep is to improve the effectiveness of coaching in the LMSC and to help implement Coaches Committee program in their specific domain. Nearly 80 percent of LMSCs have appointed Reps, with the remaining 20 percent still begging for volunteers. In the coming year, we will work to have the Coaches Reps become more productive and to network with other reps.

New to the Coaches Committee in 2000 was the International Coaching Program. Three coaches, one head coach and two assistants, were selected and paid stipends to assist the American delegation at the World Masters Championships in Munich. All three coaches learned the German language, or at least how to ask for directions to the restroom. Preliminary reports indicate that the program was a success, with suggestions made to improve the coaching in New Zealand in 2002.

Several clinics have been held to educate both coaches and swimmers. The Coaches Committee played in integral role in the USMS/USA Swimming Camp at the Olympic Training Center in Colorado Springs. Three coaches and one intern, along with a strength/flexibility expert, served the needs of the 12 campers. Five USMS Mentor Coach and Swimmer clinics were held around the country, and two USMS Open Water clinics offered advice from the experts on riding the waves.

In its never-ending quest to further the intelligence of the swimming community, the Committee uses several means, most notably its *Coaches Committee Quarterly* and *Ask the Coach*. The "CCQ" is now being sent to all coaches in the national database and poses interesting and thought-provoking questions to a panel of coaches. In SWIM, *Ask the Coach* addresses commonly-asked questions from swimmers. Also, the video and book libraries provide educational items for USMS members. Plans call for a Coaches Links page on the USMS web site that will serve as an educational hot spot for Masters coaches.

You'd think this is enough, but we ain't done yet. A coaching seminar is being planned for the USAS convention on Wednesday afternoon, 1:00-4:00 pm. If you have reading this prior to convention, make plans to drop in and hear some of the country's top Masters coaches speak on various topics.

A unique program to aid in the education of swimmers is the Snooper Loan Program. Two color Snoopers were purchased in the last year and are available from the Committee for a rental fee. The Snoopers are a popular item for swimmers and coaches wanting feedback on their strokes. If you haven't been Snooped, you're missing out big time, and you probably think your strokes are better than they actually are.

The On-deck Coaching Program has been a hit at national championship meets, the convention and on a regional basis. Roughly 12 to 20 coaches participate in the program at each of the national functions, allowing sprint lanes and workouts to run efficiently and effectively.

The Committee continues to work closely with the Masters Aquatic Coaches Association (MACA) to serve Masters coaches in education, leadership and professionalism. An important MACA project in the works is updating the certification courses offered to Masters coaches.

The Coaches Committee is developing a survey on Masters coaching compensation. The survey will be distributed in the Coaches Committee Quarterly and through the website.

The Coaches Committee is working with our USMS Sponsor Liaison with regard to support for our On-deck Coaching Program and our quarterly newsletter.

The Coach of the Year Award, sponsored by Speedo, will be presented once again at the USAS Awards Banquet, where, hopefully, the skit will be funnier than last year.

COMPUTER ON-LINE – Jim Matysek

The USMS web site has continued to grow steadily this year, along with our membership's dependence on the site. Since the 1999 convention, the daily visitation rate to our site has increased

by about 50%. Members have now become accustomed to receiving services on the web that were never available before the past year or two such as immediate nationals results, top ten publication before the hard copy booklet comes out, event listings from around the globe, on line entries for nationals, and posting of heat sheets prior to nationals. With increased demand for services, several projects have fallen behind due to time constraints, including web publication of the rule book, maintenance of the LMSC officer listing, and e-mail alias processing. We are working on ways to further automate some of these tasks so that future delays can be avoided. As our organization moves forward, we will be attempting to integrate web publishing into more of the daily tasks of the overall administration rather than as an afterthought, which typically results in duplication of efforts. Modifying processes to include web publication of information will take time, but we will get there eventually.

Our sponsorship agreement with Mindspring will end this fall, and we are currently looking for a new place to host the web site. Our site has grown in size, popularity, and sophistication to the point where we are considering moving to a dedicated web server as opposed to the shared services we have used to date. A dedicated server would also allow us the flexibility in the future of being able to provide more member services that are not possible with a shared server. Moving the web site is being discussed and planned by the committee now, and may be complete by the time we all arrive at convention, or it may be a major topic of discussion at our meeting.

The half-year report contained the information on the Pan Pacific Masters Swimming Championships held in Perth, Australia on the 16-24 October 1999. Those attending from the USA were Nancy Ridout, June Krauser, Ernie Leskovitz (60-64) from Hawaii, Frank Warner (50-54) PMN, Matthew

Shirley (35-39) RMS, Doug Woodring (30-34) TOC and Janet Kavadas (65-69) PNM. To date no one had bid for the Pan Pacifics for 2001.

Ginger Pierson and Bill Tingley completed the International Contact list for USMS and it is now on the USMS web site.

The expectation that Munich 2000 would be one of the largest FINA World Masters Swimming Championships of all time proved all too true! More than 7,400 participants from around the world converged on Munich to participate in the VIII FINA World Masters Swimming Championships for swimmers, divers, open water swimmers aged 25 and over, synchronized swimmers aged 20 & over and water polo players 30 and over.

The competitions took place in the Olympia Schwimmhalle, site of the 1972 Olympic and Dantebad, site of the 1072 Olympics in water polo on July 27 – August 7, 2000. Both facilities were in great shape. The local organizing committee, under the leadership of Marion Hillenbrand and Klaus Huber worked extremely hard to ensure that the event was a success – which it was. The hosting club, Manner-Schwimm-Verein Muchen, provided an extensive variety of social events for entertainment in Munich – the capital of Bavaria.

In all there were 429 individual swimming events plus 14 relay events, 75 diving events, 28 synchronized swimming events and 65 water polo teams playing 6 tournaments. 591 competitors were entered in the open water swimming in 22 events at the Ruder Regatta Strecke with the water temperature at 18 C. In the swimming events, 47 world records were broken or equaled.

Onward to Christchurch 2002, New Zealand for the IX FINA World Masters Swimming Championships to take place in the Queen Elizabeth II pool complex March 21 to April 3, 2000. Christchurch, the city of sport awaits us.

We had one last meeting of the FINA Masters Committee for this quadrennial, as a new committee will be announced in Sydney.

OFFICIALS COMMITTEE – David Diehl

The Executive Director of the College Swimming Officials Association (CSOA) was contacted and gave his approval to use that organization's certifying process as a USMS approved certifying body for USMS meets. The rule differences for NCAA/YMCA were added to the 2000 USMS Rule Book.

The rule changes for USMS that took effect as of January 1, 2000, were sent to all LMSC Chairs, Officials Chairs and Newsletter Chairs.

The guidelines for the USMS Officials Committee liaison to the national championship meet were finalized and sent to the appropriate individuals (Eric Norlund for short course and David Diehl for long course). Eric was not able to attend the meet at the last minute and Michael Lemke agreed to be the liaison.

A proposal was written and sent to the USA Swimming National Officials Chair (Pat Lunsford) that would allow people to be certified through USA Swimming by working a combination of USA and USMS meets. Prior to sending to the USA National Officials Committee, draft copies were sent to the USMS National Officials Committee members and other appropriate Masters administrators and officials for comment. The USA National Officials Committee reviewed the proposal at their February meeting and agreed in principle to the proposal. Pat Lunsford apologized for the delay in responding

but he did appoint a sub-committee under Pauline Hubbell to coordinate this effort. A finalized proposal will be presented at the Convention, if not before.

Work has begun to set up an Officials Page on the USMS web site with pointers to the USA Swimming Officials web page. Coordination with the USMS Computer On-line Committee Chair (Jim Matysek) is on-going. Information has been provided to the USMS Web Master (Jim) for use in creating the officials page. PLANNING COMMITTEE - Nancy Miller

The Planning Committee has had an active year. We continue to be very interested in the financial health of the USMS Endowment Fund and are actively encouraging the Sports Medicine Committee, among others, to develop grant applications to potentially fund programs which are of particular interest to them. I believe there is a need for a central clearinghouse through which all grant applications must pass where they will be reviewed by established, objective criteria and then ultimately accepted or rejected. This mechanism has yet to be established.

At last year's convention, Planning was successful in its plea to have a USMS liaison position created with regard to the National Senior Games. Scott Rabalais was appointed to this post, and he has met with Phil Godfrey (the Vice President of the National Games) and Bill Bankhead (the CEO of the Local Organizing Committee for the 2001 Games). According to Scott, these individuals are excited about building the relationship between the two organizations in a very positive way which should benefit us both. We will continue to explore ways in which this can best be accomplished.

Also at the last convention, Planning requested that Marketing develop a pre-packaged booth and materials display of USMS information which could be sent or taken easily to aquatic and non-aquatic events all over the country for the purpose of promoting our organization. Debbie Morrin, the new Marketing Chair, has agreed to make this a priority.

But the largest portion of our efforts this year has been devoted to the continuing development of the Strategic Action Plan. This document has seemingly taken on a life of its own as it morphs and changes with each bit of input received, resulting in an ever-evolving entity. While this sometimes creates difficulties for those working on it, it nevertheless makes perfect sense when viewed in light of the fact that the Plan should and does reflect many, many very different individuals and all of their varied thoughts, perspectives, hopes, and beliefs.

The Dixie Zone Top Ten for SCY and LCM is now on the web site. However, Karen Crossen has resigned and we will be discussing ways of keeping this valuable Top Ten Times current. Also, our Records have to be updated. Anyone interested in volunteering please let me know.

On the 22nd of March I received an e-mail from New Zealand informing me that Christchurch had been awarded the 2002 FINA World Masters Swimming championships for March 21 – April 3, 2002. Start planning.

GREAT LAKES – Melissa Rinker, zone representative

The Great Lakes Zone was proud to host the 2000 SC National Championships at the IU Natatorium this year. There were 1300 participants, of whom helped set 108 USMS National records! In addition, Mel Goldstein and "crew" hosted a successful National One Hour Postal Swim in January, and the National One Mile Open Water Championships in June.

Melissa Rinker is in her first year as chairman, trying to promote communication and competition within the Zone. A mythical "GLZ Inter-state championship meet is being tabulated with results to be distributed at this year's Convention.

7 out of the 8 LMSC's are publishing newsletters and state records.

Masters Swimming moved into the new Century in grand fashion in the Northwest. Rogue Valley Masters of the Oregon LMSC hosted the first Open Water National Championship ever held in the Northwest. With over twice as many entrants as any previous 10K Championship, a beautiful setting, outstanding weather and water conditions and the wonderful attitude of the host team the event was truly one that the swimmers will not forget. PNA hosted the 5K/10K Postal Event and Rogue Valley Masters just had time to catch their breath after the 10K and then they hosted the 3000/6000 Postal Event. This same commitment continues in 2001 as the LCM Nationals returns to PNA and the superb Federal Way Pool and the 2 mile Open Water Championship will be held at Elk Lake in Central Oregon.

Jeanne Ensign of PNA is the USMS Treasurer; Hugh Moore of PNA is the USMS Zone Chair; Sally Dillon of PNA is the USMS Long Distance Chair; Elin Zander of Inland Northwest is the USMS Legislative Chair; Sandi Rousseau of Oregon is the USMS Championship Chair; June Mather of Oregon is the USMS Internal Auditor; Ginger Pierson of Oregon is the USMS Ad Hoc ISHOF Chair; Bill Volckening of Oregon is the USMS Swim Magazine Editor; Doug Garcia of Inland Northwest and Bill Volckening of Oregon coordinate the USMS Mentor Clinics and the USMS Nike Championship Clinics and serve as MACA Co-Reps for the Northwest; Dan Gray of Oregon coordinates the USMS Open Water Mentor Clinics; and Suzanne Rague of Oregon is the immediate past USMS Controller and served part of 2000

The Northwest held three Zone Championship meets this year. The MAC Club of Oregon hosted the SCM Zone meet. This meet rewrote the Records Book when over 90 new Zone Records were set. Inland Northwest hosted the SCY Zone Championships at Washington State University in Pullman. The Oregon LMSC hosted the LCM Championships at Mt. Hood Community College. Mentor and Nike Clinics were held in PNA, Montana and Alaska and Oregon hosted an Open Water Mentor Clinic. Six newsletters a year and email provide the communication network to keep the Northwest informed and up to date. The Executive Challenge Relay at Short Course Nationals gave the

Northwest swimmers a fun opportunity to come together and swim as one relay. The 21st Century is off to a great start in the Northwest and we are looking ahead to another great year in 2001.

OCEANA - Richard Smith, zone representative

Oceana's Pacific and Hawaii LSMCs continue to move forward under the fine leadership of Julie Paque and Janet Renner. One of Pacific's main thrusts for the year has been the recruitment and retention of members, coaches, pool time and facilities. This has contributed greatly to Pacific's growth pattern. This has been a year of many excellent sanctioned pool and open water swims for the competitive swimmers who have responded with many fine swims and records. Pacific is now looking forward to hosting the 2001 USMS Short Course Nationals in Santa Clara, California and will be planning for the appearance of Masters from all parts of our great organization. Hawaii has been building its leadership group and has had a year of firsts. First website, first newsletter (one that can be received by email), first LSMC annual open meeting, and first for establishing a system of inner-island communication by inviting representatives from the various islands to become members of the LSMC Committee. Keep you eyes on Hawaii and you will find their group becoming another strong spot in our USMS program. Due to the time and distance factor Oceana has yet to have a Zone swim meet but down the line--------who knows???

SOUTH CENTRAL – Larry Wood, zone representative

The South Central Zone is comprised of nearly 2000 swimmers in six LMSCs (Border, Gulf, South Texas, North Texas, Oklahoma, and Arkansas). During the past year, the zone has maintained an active meet schedule with each LMSC hosting their usual competitions. Most LMSCs have increased both registrations and attendance at meets this year. We exchange newsletters among the LMSCs to encourage communication. Both Gulf LMSC and North Texas LMSC maintain websites which list all of the events held within the zone. We are using the web to publish meet entries. The Gulf LMSC uses an e-mail list (with voluntary participation) to notify members of LMSC meetings, events, meet schedule, and minutes of the meetings.

The South Central Zone SCY meet was held in Oklahoma City the first weekend of April, with approximately 150 entrants. South Texas chartered a bus for our members in order to show our support for Zone meets in neighboring states. Our Long Course Zone meet was hosted in July in El Paso.

SOUTHWEST - Clay Evans, zone representative

At last year's convention, the zone rep election ended in a tie. As a result, Judy Gillies and I are sharing many of the responsibilities. This year I am listed as the official zone rep and next year Judy will be listed.

We have had a successful year with all three LMSC's growing in size compared to last year. Although it was not a large growth, we all feel healthy. We have planned a Southwest Zone open water Championship in Lake Las Vegas but unfortunately we lost a sponsor hotel and are rushing around trying to find another sponsor. Our event is scheduled for October 21. This will be a much later date for an open water swimming but we feel that it will generate enthusiasm in the four states of our zone: Nevada, Arizona, New Mexico and California. Our hope now is to move the event into Lake Mead. However it is taking a long time to secure permits from the federal government. Our emailing system in the SPMA is working quite well. Once every two weeks we send out a message informing members of events and results. We always ask that they link over to the web sites: SPMA.NET and SWIM.NET. Our ocean swim results are looking very good on our web pages. This has had dramatic results in

communication for our SPMA LMSC. We hope to get out our first zone email before convention. We will need to get a general email out if we can get our open water swim in Lake Mead.

Our main goal this past year was to coordinate "Zone Meets". There has been much discussion, but no actual results. Our plan is to have one Zone meet per season, SCY, SCM, & LCM, each in a different LMSC. Hopefully next year.

AD HOC HISTORY & ARCHIVES - Carl House

President Nancy Ridout created the ad-hoc History and Archives Committee after convention in 1999, to give official stature to its stated mission: to construct permanent recorded history - both hard copy and electronic - of United States Masters Swimming. As our first year comes to a close, we've made a lot of progress building on all the work that has come before. We think Dorothy Donnelly, who started our committee, is proud of us. In addition to the people named below, we especially want to thank Sally Dillon and Nancy Ridout for their major contributions to the work of our committee. The most important next thing for us to do is to identify resource people in all LMSC's who will help us make the information on their LMSC be as good as it can be.

Validating All-Americans

Barbara Dunbar has led our effort to make sure our historical record of Pool and Long Distance All-Americans is accurate. This involves comparing the All-American data with the original source documents including national meet results, some regional meet results, Top Ten, and the All-American announcements. This effort is nearly complete. The result is that names are spelled correctly, most birthdays are included to assure proper identification, and LMSC and club affiliations have been filled in for most All-Americans. A recommendation has been submitted to the Executive Committee to add 26 swimmers who were erroneously omitted and to delete a few foreign or USS swimmers who should not have been included because they were not registered with USMS. This effort is continuing and it is probable that more errors of inclusion or omission will be discovered and corrected.

The Pool and Long Distance All Star database will also be verified.

Effort continues to obtain birthday and affiliation for the unidentified All Americans by researching old masters results, newsletters, and documents. The most important source of continuing help and progress on this is expected to come from LMSC people providing information on their people. Lists of unidentified people are available at our website or by request from the National Office (who will refer the request to our committee).

Championship Meet Results

Craig Tribuzi has been accumulating a database of top finishers at each USMS national championship meet and age group record holders every year. The 1970's are complete and he's seeking computer files to complete his information for the 1980's and the 1990's.

Olympians in USMS

Gail Roper is leading the effort to identify every Olympian who has participated in USMS. This will include some foreign Olympic aquatic competitors who later moved to the U.S. and some American Olympians from other sports. The list includes 156 people so far. The database includes their Olympic year(s), the events they competed in, the years they competed in USMS, and other information like maiden and married names and birthdates.

Stories and Oral History

Stories about our people in Swim Magazine and other national media and in LMSC & club newsletters are important to our archives. Meegan Wilson has led the effort to collect these stories and put them in a form for safekeeping and for display. We have stories about 223 prominent USMS people on our website. There are several dozen more people about whom we'd particularly like to have a story. And we have a backlog of dozens of stories that need to be typed so we can use them in our digital archives. Volunteers are needed for typing the most important of these stories.

The USMS Oral History began at the 1999 convention meeting chaired by Edie Gruender. Edie and Helen Bayly and others set up a booth at SC Nationals in Indianapolis in May to explain the Oral

History and to encourage people to contribute. So far, 24 people have made contributions to our oral history.

Hard Copy Archives

The USMS Historians, Ham and Mildred Anderson, Joan Smith and Edie Gruender, have kept safe for us an extensive collection of articles, newsletters, photographs and other artifacts over three decades. These are now being cared for at the homes of Joan Smith and Edie Gruender. We are in conversation with the International Swimming Hall of Fame about how they might work with us to provide a permanent home for our archives with professional curatorial care. It is hoped that other people who have extensive personal archives will entrust them to ISHOF as well.

Historical Registrar Files

The USMS National Office provides support to the History & Archives Committee by researching past individual and group memberships in printed reports (Tracy Grilli) and electronic files (Esther Lyman) as needed. Printed reports are available from 1986. Electronic files are available from 1994. All available electronic files have been combined into multi-year files and re-sorted by date of birth to facilitate research. This setup is particularly useful for identifying swimmers who have registered with or been known or reported by different names over the years.

Database of Name Changes

Throughout our Archives, we want to keep track of the swimming performance of our competitors over the years. This makes it important that we know about name changes, most often occurring through marriage. Gail Roper has taken on the job of building a database of name changes, for whatever reason they might occur. This effort is just beginning. We have a few hundred names so far. We'll work out the means for making it easy for our database to be kept up to date.

Photographs On-Line

Our on-line archives now include 563 photographs that have been scanned and catalogued and so are fully integrated with other information in the on-line archives.

Swim Magazine Photos

Swim Magazine has agreed to make available to USMS all the photos that have appeared in their magazine since 1995. The photos from each issue are being given to us on CD's and as we receive them thumbprint photos are placed on our website. USMS volunteers are needed to identify the photos that might be useful to us and to add descriptions and credits to our catalogue. This should be done by comparing the particular issues of Swim Magazine with the thumbprint photos and then adding who is in the photo and who the photographer is from the text of the magazine. 1535 photos have been received thus far and every two months we get another 60 or so photos as each new issue is published.

On-Line Systems Development

The easiest way to access our archives is on the world wide web. They are available through www.usms.org or through www.swimgold.org. Our archives website now includes 5,254 pages with 155,910 links connecting related information. We have information on 11,340 USMS swimmers, and, we can bring up what we have on any of these 11,340 people with a single uncomplicated URL. We believe that the total number of All-Americans ever named is 3,493. But, there are still 269 All-Americans who are not claimed by any LMSC and there are 446 All-Americans whose birthday we don't know. So, there is more to do. Our objectives are these.

- To maintain accurate and up to date information on the major swimming accomplishments of our swimmers in our sanctioned events
- To keep safe and available a wide range of historical items and information
- To make some of this information easily available on the web
- To develop procedures so that as much of our work as possible will be automated
- To enlist the help of people throughout USMS to ensure accuracy and fairness of representation.

AD HOC LEGAL COUNSELORS - Jeanne Crouse

Our Committee has been asked to consider some most interesting issues at this Convention. If you read our mid-year report, you'll recall that we are in the process of crafting a suggested privacy policy for USMS. By *privacy policy*, we mean the organization's policy on marketing or otherwise disseminating any personal information that USMS obtains about its members. Meanwhile, those other governing bodies (Congress and the President) enacted a federal Electronic Signatures In Global and National Commerce Act, which goes into effect this October. This new law (nicknamed *E-SIGN*) was passed to promote the use of electronic signatures in private commerce. Essentially, it seeks to speed up the legal world*s acceptance of e-commerce by making electronic signatures equivalent to traditional pen-and-ink signatures. On a practical level for us swimmers, this means that in the not-too-distant future we should be able to join USMS and register for meets in a truly paperless process.

After E-SIGN became law, several USMS Committees and that other famous head of state, President Ridout, asked our Committee to review the statute, determine whether it can be applied to USMS business, and, if so, devise implementing procedures. Other USMS Committees that we'll need to coordinate with in this process include our Championship, Computer On-Line, Insurance, and Registration Committees (not to mention our insurance agents).

If you're interested in electronic signatures or privacy issues or just like to watch a bunch of lawyers argue with each other, please join us when we meet at convention. AD HOC PROFESSIONAL MANAGEMENT - Hugh Moore

At our "mid-year" meeting in January, the Executive Committee discussed the current status and future direction of compensated positions. We unanimously agreed that the Professional Management Committee should address compensation for the Webmaster and USMS SWIM magazine editor. The Executive Committee submitted an initial proposal, which was discussed by the Professional Management Committee via emails and revised.

The Professional Management Committee includes all members of the Board of Directors. Additionally, the special assignments listed in the Rule Book were included in the email exchange. They have a voice-only role and are not voting members of the committee.

The following proposal will be discussed at the Board of Directors meeting on Wednesday, October 11th. If the Board of Directors adopts the proposal, the House of Delegates will consider it.

"Keeping in mind that everyone may be reimbursed for expenses incurred on behalf of USMS, the Board of Directors believes the positions of USMS Webmaster and USMS SWIM magazine editor are essential to our mission, involve a time commitment and expertise well beyond what can be expected of a volunteer, and should receive an honorarium for the year 2000. We recommend that USMS Webmaster receive the sum of \$10,000 and that the USMS SWIM Magazine Editor receive the sum of \$5000. Furthermore, we believe that these two positions should receive compensation in the future. The compensation amounts, hiring methods, and management of these positions will be controlled via guidelines proposed by the USMS Executive Committee and approved by the House of Delegates."

The Executive Committee and the Professional Management Committee are working on proposed initial guidelines.
