The USMS ISHOF committee is constantly striving to improve its protocol for selection of a candidate to propose to The ISHOF. ANNUAL REPORT

The historical databases created by the History and Archives (H&A) Committee have been integrated into the USMS Enterprise database almost completely and no longer will be solely maintained by the H&A Committee. The H&A Committee and its representative, Meegan Wilson, will be working with the USMS webmaster to develop the procedures permitting integration of historical documents, stories and articles about swimmers, oral histories, and photographs into the USMS Enterprise database. Timely and accurate integration of historical and archive materials will progress as new procedures are developed by the USMS webmaster. Issues requiring research or clarification will continue to be performed under the lead of committee representative Barbara Dunbar.

Since the 2002 convention, the largest ongoing H&A project involves annotating and cataloguing over 3,000 images in the archive photo gallery. The highest priority has been given to the images received from Swim Magazine which are being annotated and catalogued by Katie Cooper and Howard Rutenberg. To date, they have completed work on 1,617 of the 2,297 images from Swim Magazine with an estimated completion date of late August.

A second project involves securing permission to use the photos from as many of the various photographers as possible. The first phase is to request permission from those photographers who are USMS members and who will hopefully give permission for use of their photos. The second phase will be to seek permission from the professional photographers most often published in Swim Magazine, then photographers known to committee members, and finally any remaining photographers.

TOP TEN

Top-Ten Tabulations for 2002 Long-Course Meters, 2002 Short-Course Meters, and 2002/2003 Short-Course Yards, were sent to the printers and distributed. The World-Record listings in these publications were supplied by Walt Reid.

The Top-Ten information is also available on the Web. The listings are being transferred to the USMS wseb site. I would like to thank Carl House for having done these listings for many years and his efforts to ensure data integrity.

Walt Reid continues to process all record applications and supplies the record information that is included in the Top-Ten Publications.

ALL AMERICANS

Individual and Relay All American tabulations were completed. The Individual list appeared in Swim Magazine and the Relay All American list was sent to all members of this Committee and to representatives of the listed Clubs. The Relay All American list is also available on the USMS web site.

QUALIFYING TIMES

Tabulations of qualifying times for National Championships were compiled for SCY and LCM and sent to the Championship Committee.

SOFTWARE FOR TOP-TEN RECORDERS

At the 2001 Convention the House of Delegates approved an expenditure of \$8000.00 to develop software to make it easier for Top-Ten Recorders to compile results from the meets that were held in their respective LMSC's for submission to this Committee in a standard format. This project was put on hold by the Executive Committee who started a Database Project with a wider scope. No action was taken as a result.

Mary Beth Windrath has made her program available to Top-Ten recorders. This is a program similar to Walt Reid's old program except that his has the capability to handle registration numbers. Several recorders are using this program now,

REGISTRATION NUMBERS

This year we have asked the Top-Ten recorders to provide Registration Numbers in the top-ten compilations to make it easier to positively identify swimmers. For the 2002-2003 SCY list about two thirds of the TT recorders have supplied ID numbers. This is a very encouraging result and I want to thank the TT recorders for their efforts. I have tried to supply the missing numbers with the result that fewer than one percent of the numbers are missing in the individual top-ten file.

The TT recorders participated in a survey to determine what kind of software they use in the compilation task and how difficult it would be for them to supply ID numbers. Ed Tsuzuki compiled the results and found that 18 % compile the results by hand and 34 % use a combination of electronic data gathering and manual data entry.

MEET RECOGNITION

Results from foreign meets are generally not automatically recognized by USMS, except meets held in Canada. This has created problems and has resulted in the need for the USMS Executive Committee to recognize some major meets after the fact.

Walt Reid has prepared a rule-change proposal for the Committee to be submitted at this-year's Convention. The proposal basically suggests that USMS recognize foreign meets that are also recognized by FINA for world record applications.
