

Breadbasket Zone Minutes



- 1.) Todd expressed appreciation to Paul Windrath, Sarah Hromada and the Minnesota Masters for their work during the USAS Convention.
- 2.) Paul updated the committee on the 1992 Long Course National Championships. He reviewed the expenses and explained that the financial status is currently break even with an estimation of a 1,000 participants. He outlined a sponsorship program. Information regarding parts on the sponsorship program will be mailed to all LMSC's.
- 3.) Zone Meets - the committee decided to maintain a one meet Zone Championships as opposed to a postal format. The 1993 Zone Championships will be held at Arvado, Colorado in the later part of March.
- 4.) Leo announced St. Louis Masters is hosting the 1993 National 5K & 10K Postal Swim.
- 5.) LMSC's were encouraged to mail each other their newsletters (to include all LMSC Chairman and Newsletter Editors in the Breadbasket Zone).
- 6.) Mel Goldstein is coordinating a National Swim Meet Schedule. All LMSC's are encouraged to send swim meet schedules to the Zone Representative, who will compile the information and mail it to Mel. Since Mel will be formulating a national list, the Zone Newsletter will not have a schedule. (Mel will mail a copy if you mail him a self-addressed stamped envelope).
- 7.) Nominations for USMS executive offices are currently being taken. Nomination letters are to be sent to Betsy Durrant (or the USMS National Secretary) by February 28, 1993. A brief explanation of the nomination process was given.
- 8.) Leo made a motion to "to express the Breadbasket Zone Committees preference to nominate a slate as one person per office." MSD
- 9.) General Discussion - thoughts about whether members from outside the Zone should be eligible to score points at the Zone Meet. Kevin Polansky highlighted possibilities of setting up testing of Masters swimmers at the Colorado Olympic Training Center in conjunction with ICAR.
