Minutes of the Ad-hoc Computer Committee

The meeting was called to order by chairman Leo Letendre at 9 AM, Wednesday September 19th. Members present were Bill Barthold, Joann Leilich, Walt Reid, and Hugh Moore. Twenty-six non-committee members also attended.

Leo opened the meeting with a description of the committee's charter. He stressed it was an opportunity to do something for the members. By using our collective resources, we can create a set of programs to handle registration, top ten, and meet management functions at both national and local levels. These would be more efficient than the current variety of programs used for these tasks. He also cited the positive results of current registration program as evidence that results of the project would be widely used.

An overview of the methods used by the committee was presented. This included creating a Functional Specification which defines what USMS wants the program to do. It describes software that we feel would be useful for Masters swimming. To aid in the development of the specification, a survey was sent to all club reps and LMSC officers. Following completion of the specification, Request for Proposals were sent to 25 people/companies. The names were solicited from response from an announcement in the USMS newsletter and from a local Clipper User's Group. The committee received 9 bids. All of them were well done and generally impressive.

A number of suggestions for additions to the specification were received from the audience. These were noted by the committee and will be added if they are possible to incorporate without increasing development costs.

The committee decided to delay incorporating an interface to electronic timing systems for 1 year. The committee will seek volunteers to aid in testing of program prior to distribution. Anyone interested should contact Leo.

The committee agreed on the following implementation plan. A set of manuals and software for all three programs (Registration, Top Ten, and Meet Management) will be distributed free to each LMSC. Additional copies can be duplicated or may be purchased at a reasonable cost which would cover anticipated upgrades. A user registration form will be included to help keep track of distribution and usage. The Top Ten and Registration portions will be supported by the respective USMS standing committees. Meet management will be supported by a volunteer in each zone which the Computer Committee will solicit.

A second session was held to select bids. Since this was a discussion regarding personnel, only committee members attended. The committee narrowed the field and setup telecons to interview two candidates. Following the telecons the committee selected the bid submitted by G. A. Sullivan. The committee unanimously recommends that the House of Delegates fund the project.
