

MINUTES  
HEARTLAND ZONE  
September 23, 1989

The Heartland Zone meeting was called to order by Chairman Pat Maley at 8:34AM. The roll was called and an attendance sheet circulated. Pat indicated voting would be by LMSC, one vote each.

The minutes of the previous Zone meeting as previously circulated were approved as written. Pat reported for the Treasurer, Jan Huneke, that the Zone treasury had a balance of \$1,950.80. Long Course results had been done, but additional patches need to be purchased. There are 3 Heartland T-shirts remaining. These are being sold at cost, which is \$10.00. The Treasurer's report was accepted as presented. Thom Tripp moved that the financial report be supplied to the Zone delegates each year prior to Convention. The motion was seconded and approved.

LMSC meet schedules will be distributed with the minutes of this meeting if available at this time. All additions to the Zone meet schedule should be submitted to Jan Huneke, 8068 Asbury Hills Dr, Cincinnati, OH 45255 by October 1st.

A bid sheet for Zone Championship meets was presented and approved with the additional specification of "seating capacity". Pat Sengstock of Central agreed to write up a brief guideline for Heartland bidding procedures for Zone Championships. It was agreed to seek a single Championship meet if a bid was received from a centrally located site, two meets if not.

1990 LC	Canton, OH	last weekend July 1990*
1990 SC	Michigan (4 possible sites)	Nov 10-11, 1990*

Zones reported no particular problem with unregistered teams in meet results. Each LMSC was asked to prepare an address list, to be submitted to Pat Maley, of teams in a 3-across label format for photocopying. Workout groups should be indicated as such.

Thom Tripp promoted the idea of having a continuous warmdown lane when no warmup pool exists. It was agreed to present this idea in each LMSC.

There will be a short informational meeting at the Zone Championship Meet in Indianapolis. Gail Dummer will arrange.

Mary Pat Maley was nominated and unanimously elected Zone Chairman for the next two years. Pat was asked to make arrangements for a convention social for Heartland following the Insurance Reception at next year's convention.
