MINUTES OF GREAT LAKES ZONE MEETING 8:30 A.M. 9-26-92

BETSY DURRANT, ZONE CHAIRMAN LED THE NOMINATION AND ELECTION OF A GREAT LAKES ZONE CHAIRMAN, SINCE DAVE BROWN CAN NO LONGER SERVE IN THIS CAPACITY. FRANK THOMPSON OF MICHIGAN WAS ELECTED TO THE OFFICE UNANIMOUSLY. FRANK HAD NO AGENDA. ATTENDENCE - EACH PERSON PRESENT INTRODUCED HIMSELF AND THEIR LMSC. ATTENDANCE SHEET WAS SIGNED BY EVERYONE PRESENT.

ZONE TOP TEN - DISCUSSION ON USING THE FALL CLASSIC IN INDIANAPOLIS IND. AS A SHORT COURSE METER ZONE MEET IN THE FUTURE. IT IS DOUBTFUL THAT THE IUPUI POOL CAN BE OBTAINED FOR MORE THAN 1 DAY. ALSO THE POSSIBILTY OF USING STATE CHAMPIONSHIP MEETS FOR THIS PURPOSE. POSTAL MEETS ALSO SUGGESTED. LMSC'S SHOULD SUBMIT TOP TEN TIMES TO SKIP THOMPSON AT THE SAME TIME THE LIST IS SENT TO WALT REID FOR EACH COURSE SO THAT A ZONE TOP TEN LIST MAY BE FORMED. SKIP EXPLAINED THAT HIS INTENTION IS TO CONTACT DAVE BROWN, FORMER CHAIRMAN, TO USE WHAT HE HAS BEGUN IN ORDER TO KNOW WHERE TO GO WITH REGARDS TO THE 1992 SHORT COURSE YARDS ZONE TOP TEN THAT EACH LMSC SUBMITTED.

SINCE REGISTRATION HAS DECREASED IN THE MAJORITY OF THE LMSC'S, IDEAS TO KEEP PEOPLE IN THE MASTERS SWIMMING PROGRAM WERE DISCUSSED. SKIP AND BARB LARSON ENCOURAGED REACHING OUT TO THE FITNESS SWIMMERS BY IMPLEMENTING IDEAS GEARED TO THESE SWIMMERS. 1000-3000-5000 YARD SWIMS, INVOLVEMENT IN POSTAL ONE HOUR SWIM IN A MEET, NAME A MONTH A FITNESS MONTH, HAVE FUN MEETS THAT ARE SANCTIONED AND NON-APPROVED. FOR A LIST OF ALL MEETS SEND A SELF ADDRESSED STAMPED ENVELOPE TO MEL GOLDSTEIN, SUBMIT YOUR MEETS TO MEL BY SEPT. 30, 1992. THESE WILL BE UPDATED AND MAILED DURING THE YEAR. MIHIGAN WILL MAKE UP A CALENDAR OF FITNESS EVENTS. KENTUCKY HAS A CONTEST FORMAT WHERE SWIMMERS LOG THEIR MILES AND ADVANCE OVER A MAPPED RIVER COURSE WHICH ENDS AT NEW ORLEANS AND A PARTY USING THAT THEME WINDS IT UP A FUN AND SUCCESSFUL DAY.

PLACES TO SWIM NEEDS TO BE UPDATED BY JANUARY 1993.
