UNITED STATES MASTERS SWIMMING, INC House of Delegates - Annual Convention Minnapolis, Minnesota September 23-27, 1992

Friday, September 25, 1992

The first session of the USMS House of Delegates was called to order by President Dan Gruender on Friday, September 25, 1992. Roll call of the certified delegates was made by Secretary, Mel Goldstein, 137 were present.

After opening comments, President Dan Gruender recognized Julie Paque, Rule Book Editor, to make a special presentation. Julie acknowledged the efforts of her predecessors Gail Dummer and Kathy Casey by presenting each with a T-Shirt that had the last four USMS Rule Book covers imprinted on them and announced that the 1993 Rule Book would be dedicated to Kathy and Gail.

The meeting was turned over to Bill Barthold, Championship Chairman. Bill recognized Hugh and Dr Jane Moore, Meet Directors, who presented Team Award banners, to 1992 LC Nationals team champions. Bill advised before bid presentations could be made the House of Delegates must first approve an out of rotation bid in accordance with rule 104.3.F (page 41). MSC to accept out of rotation bid.

Bidder for 1994 SC National Championships - RIO SALADO SWIM CLUB-Tempe, Arizona. By unanimous vote the 1994 SC National Championships was awarded to Rio Salado Swim Club, to be held May 13-16, 1994.

Bidder for 1994 LC National Championships - BUFFALO, NEW YORK - By unanimous vote the 1994 LC National Championships was awarded to Buffalo, New York, to be held August 25-28, 1994.

President Dan Gruender thanked all bidders then made a few brief announcements. MSC to adjourn. Meeting adjourned at 8:55 PM.

Saturday, September 26, 1992

President Dan Gruender called the House of Delegates to order at 9:00 AM, Secretary, Mel Goldstein called roll of the certified delegates - 151 present.

President Gruender called for reports from the respective committee chairmen. To move the convention business in a more efficient manner chairmen were asked not to read their reports, but to highlight their submitted reports, which were distributed to each of the delegates.

REGISTRATION (Joann Leilich) reported the contract with USMS Registrars Bill and Diane Black had been renewed for another two The committee is studying a "rolling registration" year. MSC to accept committee report.

Over the past year USMS lost several Masters swimmers, Frank McKinney, Pete Buckley, Ashley Harper and Kevin Kelly. A special memorial service was presented on behalf of Kevin who was very active in USMS and MSI activities. A collection was taken from the House of Delegates on Kevins behalf so we could inscribe his name and Masters Swimming International on the "Walk of Fame" at the International Hall of Fame, in Ft Lauderdale, Florida. The morning session was recessed for lunch to reconvene at 1:00 PM.
