USMS HOUSE OF DELEGATES MEETINGS Cincinnati, Ohio October 1-3, 1998

THURSDAY, OCTOBER 1, 1998

President Nancy Ridout called the meeting to order at 9:20 a.m. Secretary Betsy Durrant called the roll of certified delegates. President Ridout asked for a moment of silence for those Masters swimmers who had passed away over the past year. They include: Ann Maguire (Florida Gold Coast), Denise Moran (Pacific), Bill Barnes (AZ), Kathy Wren (CO), and Jean Ditsworth (AZ).

Members of the Executive Committee gave brief reports of their activities. President Nancy Ridout referred to a letter she had written to FINA protesting the exclusion of the Israeli team at the FINA World Championships in Casablanca and the reply she had received. Zone Chairman Hugh Moore called on Richard Smith to report on the election of the Zone Chairman. Richard reported that no nominations had been received other than the nomination of current chairman, Hugh Moore. Additional nominations were called for, there were none. It was MSC (Moved, Seconded and Carried) that Hugh be elected as Zone Chairman by acclamation.

AGE DETERMINING DATE

The eligibility of a participant for a particular age group will be determined by the age as of the day of the swim.

adjusted for NQT purposes by subtracting the <u>adjustment</u> times (in seconds) from the actual time achieved. The specific adjustments for each age group and sex are found in Appendix B. The adjustments shall be determined every four years starting in 1998. The adjustment times for men and women competitors shall be calculated by multiplying the time adjustment in the following table by the ratio of the 200-yard freestyle national record for the age group to that of the 25-29 200-yard freestyle for men and women respectively. The values in the following table shall be those determined and used for the same purpose by USS.

Note: Records and Top Ten, etc., are to be actual times swum, not adjusted for altitude.

.5 First and last names of <u>eligible</u> relay swimmers, their ages, and order of swimming shall be <u>submitted on a relay entry form or card</u> to the clerk of course (if used) or to the head lane timer. Any changes in names of the competing swimmers or their order of swimming <u>must be declared to the head lane timer</u> prior to the start of the relay heat in which such team is entered. No changes will be permitted thereafter.
