Reports from the chair (Donn) The ePostal Modernization Task Force recommendation. Dawson said we will have this posted on the forum on Friday, June 23 so that everyone has an opportunity to read and review prior to the LDC taking action. These will be an action item.

2. Bob will leads us through the final rules proposal (we hope), but keep in mind the July 10 deadline for other committees to send us possible rule proposals, so we're not finished yet.

Vice chair (Ali)- Three ePostal bids for 2019 have been received. Still waiting for 2019 Open water bids, so please reach out to your club to see if there is any interest in bidding for these events.

Vice president (Chris) A lot of great thought and input went into preparing the report information, so I want to recognize and thank the task for members for their contributions: Fitness - Karin Wegner, Brian Cummings/Long Distance - Ali Hall, James Biles/National Office - Dawson Hughes, Casey Keiber/Board of Directors - Skip Thompson, Chris McGiffin

The first tab of the report provides some background information about the task force and the rationale behind the proposed changes. The second tab is the worksheet that the task force used to build out the proposed postal challenge series event information, as well as document the questions raised with current responses. Keep in mind that this report is meant to summarize the proposals and does not dive too far into implementation details. Several questions remain open, and will likely require additional assistance from both Fitness and Long Distance committees.

The goal is for both committees to entertain a motion in support of the task force recommendations, then focus on discussion related to questions, clarifications and possible revisions. I do hope that the time spent by the task force helps to keep the review/discussion effective and brief so that other committee business can be covered.
