# Topic: LDC Meeting - October 27, 2024

The meeting was called to order at 8:00pm ET:

1. Welcome and roll call.

- 2. Reports from the chair (Phyllis) and vice chair (Catherine) and vice president (Robin) and USMS National Office (Jay) and (David M)
  - A. Chair: discussions at Relay about the upcoming slate of open-water events.
    - 0. Portland Bridge Swim is interested in the Ultra Marathon distance. Scheduled for July 13, 2025
    - 1. Overview of USMS Relay, and that there are 2 individuals interested in joining our committee.

#### B. Vice Chair:

- 0. Charlottsville, VA: interested in 2-mile and 1-mile cable swims, May 31 (both on the same day)
- 1. Thanks to Nicki and Jim for edits and additions to the Virtual Championship Operational Guide which is now completed. Phyllis, Jim and Catherine are looking at OWNC Operational Guide. And will look at simplifying tasks for OWNC hosts. Any committee members are welcome to join the sub-committee.

### C. Jay:

- 0. 2024 USMS 5K/10K Virtual Championship has concluded. Results posted and awards/caps have been mailed... 148 finishers in 5K and 64 for 10K (up from 138 and 53 last year).
- 1. 2024 USMS 3000/6000-yard Virtual Championship underway through Nov. 15. There are 155 registered swimmers so far.
- 2. 2025 Open Water Nationals in Sarasota at Benderson Park on April 4-5
  - 0. 1 mile race on Friday afternoon and 5K race on Saturday starting late morning
  - 1. USA Swimming and host club Sarasota Sharks are on board with the plan
  - 2. Working around USA Swimming schedule... their races will be on Friday, Saturday, and Sunday so USMS members can spectate
  - 3. Possibility of hosting a clinic led by a National Team member to benefit the USA Swimming Foundation
  - 4. Awaiting confirmation from Benderson Park (they've been in cleanup mode from Hurricane Milton) so we can announce publicly
- 3. Sanction fees will be waived for 2025 and beyond, per the new USMS guidelines.
