### **SANCTIONS REPORT**– Frank Thompson (Skip)

Overall attendance at 'bigger' meets was down – however Michigan Masters offered 2 new meets this year.

Entries for 2011 State Meet was about the same as last year

On-line entries for this year's meet dramatically increased – 322 online entries  
14 paper entries

In 2010 there were over 100 paper entries.

In order to accommodate the increasing number of people wishing to swim the 1650, 3 heats were swum early on Friday. This enabled more people to swim and session ended at a reasonable time on Friday evening.

More options/improvements will be explored for upcoming State Meets.

19 swimmers represented Michigan at the Short Course Nationals in Mesa, AZ.

Hopefully there will more at Long Course Nationals in Auburn, AL.
