Opening:

- 1. The meeting was called to order at 5:01 EDT.
- 2. Attendance and determination of quorum: quorum was reached with 16 voting members present.
- 3. Approval of previous minutes: the minutes of the April 14, 2019, OWC meeting were approved.

Executive Reports:

- 1. Report from the Chair—Bob Bruce. Done during subcommittee reports.
- 2. Report from USMS Vice President—Donn Livoni. Donn reported on the work of the UMS Open Water Strategic Task Force; topics included ongoing work on sanctioning, OEVT fee, partnership with USA-Triathlon for several events this year, and insurance. He answered several clarifying questions.
- 3. Report from USMS Open Water Safety Coordinator—David Miner. David reported that 49 events have been sanctioned this year (including 11 dual-sanctioned events with USA-Swimming) and noted that 38 Safety Directors and 60 Referees have achieved USMS certification. He answered questions about certification window (currently three years) and actual certificates (none yet).

OWC goals & measurements for 2019: "The OWC goal is to promote the development of and participation in USMS open water swimming, and to support quality open water swimming experiences for adults in line with the Vision, Mission, Values, and Strategy of USMS. The measurement of this goal will be the quantity of

events, swims, & splashes, the quality of those experiences, and other metrics that will help us measure our progress to accomplish these goals."

Subcommittee Reports:

- 1. <u>Open Water Development & Promotion Subcommittee</u>. Purpose: To generate real, actionable ways to develop and promote open water swimming. This is the central purpose in the committee definition. Chair & Members: Chair: Will Reeves. Members: Denise Brown, Lynn Hazlewood, Jim Kennedy, Karen LeFebre, Joe Linford, Andrew Magazine. Report: Will Reeves gave a large report which stimulated much discussion. Communications: subcommittee favors a forum on the USMS website that included LMSC Chairs, LMSC Open Water/Long Distance Chairs, and OWC members (possibly LDC members too). Development: subcommittee favors information about open water practices to be included on the website, and publication and promotion of what groups are having open water practices in their local area. Club Finder: It was noted that clubs can add additional places to swim (i.e. open water practices) on the USMS website as well as LMSC & their own websites.
- 2. <u>Open Water Guide to Operations (OWGTO) Subcommittee</u>. Purpose: To review, revise, format, and communicate the contents of the OWGTO. Chair: Bob Bruce. Members: Becky Cleavinger, Lynn Hazlewood, Eric Hektner. Report: none, due to lack of time.
- 3. <u>Rules & Legislation Subcommittee</u>. Purpose: Working as a joint subcommittee with members from both OWC & LDC, examining & vetting rules proposals and bringing these proposals for consideration to the OWC then the LDC (although proposing rules to the USMS HOD is an LDC function, we have chosen in recent years to have this group work across both committees for thoroughness). Chair: Bob Bruce. Members: Becky Cleavinger, Lynn Hazlewood, Will Reeves. Report: none, due to lack of time.
- 4. <u>Safety Education Subcommittee</u>. Purpose: To review any new or ongoing business to the OWC relating to safety, and to review the documents and process of safety planning with the Open Water Safety Advisor. Chair: Bob Kolonkowski. Members: Kim Elsbach, Rory Grigull, Jim Kennedy, Peter Lee. Report: Bob Kolonkowski emailed materials to teach member of the OWC for review.
- 5. <u>Event Management Subcommittee</u>. Purpose: To prepare material for seamless presentation of events and to develop the training a course on event development & management for Event Hosts/Event Directors (first piloted in presentation in 2015). Chair: Karen LeFebre. Members: Jenny Hodges, Joe Linford, Helen Naylor. Report: Karen LeFebre reported that the subcommittee has compiled a large draft for review.
- 6. <u>Officials Subcommittee</u>. Purpose: To evaluate current practices in officiating USMS open water events and to develop materials to improve this. Chair: TBD. Members: Rory Grigull, Peter Lee, Helen Naylor, Will Reeves. Also Jim Davidson from the LDC. Report: none, due to lack of time.
- <u>Awards Subcommittee</u>. Purpose: To manage the process for selecting our annual Open Water Service Award, and perhaps exploring the honoring of USMS open water "pioneers". Chair: Jenny Hodges. Members: Bob Kolonkowski, Will Reeves. Report: Jenny Hodges has solicited LMSC Chairs & Open Water Chairs for nominees for the Open Water Service Award.
- 8. <u>Open Water Swim Training Subcommittee</u>. Purpose: To develop guidelines and materials for coaches to prepare swimmers for open water swims. I hear that the Coaches Committee is considering adding such material to the Coaching Certification program, so we may have an opportunity to work jointly with this committee. Chair: Mark Johnston. Members: Denise Brown, Kim Elsbach, Jim Davidson, Andrew Magazine, Helen Naylor, Kate Stephensen. Report: Report: Mark Johnston reported that he had set up a Google page for his subcommittee to review and annotate open water training material developed by various groups.
