ANNOUNCEMENTS:

The questionnaires submitted by each candidate for USMS Officer are in the hospitality room.

The insurance committee has recommended that beginning September 1990, the registration APPLICATION contain a liability waiver to be signed in addition to the waivers signed before competing. These forms should be kept on file 1-2 years.

Past policy did not require the swimmer to sign a Registration Form when re-registering. A clarification of this policy is requested from Legal Counsel.

3. Distribution of USMS Mailing Labels/Lists. This was reconsidered and recommended to continue present policy.

4. The following are suggestions to help educate swimmers to register with the same name they use for competition:
 - . Registration Forms and all swim meet Entry Forms should contain the following statement "Use the name you want to compete under."
 - . Require a copy of the Registration Card with all swim meet Entry Forms.
 - . Computerization helps because the Registrar supplies a list of names and registration numbers.
5. The LMSC Registrars have been complying with the request to mail information of the 'Role of the Medical Exam.'
6. The following topics were suggested for the USMS Newsletter:
 - . use the same name each year
 - . transfer procedure.
 - . It was also mentioned that an attempt is needed to draw the reader into reading the article, (i.e. Now You Can Call Me RJ, But you Doesn't Have to Call Me Johnson).
7. It was reported that the National Registration Program is not completely "debugged" at this time. A short discussion was held concerning the use of the LMSC Registration Program.
8. The Registration Committee recommends Bill & Diane Black be awarded the contract for National Registrar beginning September 1990.
